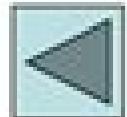


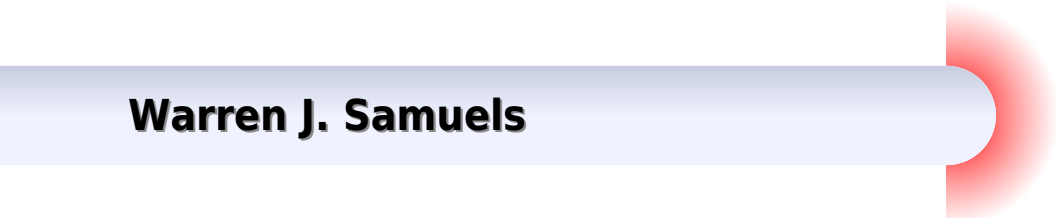

from separate and not subordinate to the political social and cultural spheres while in planned systems the economic sphere is embedded in the noneconomic spheres To be sure market economies are strongly affected by political and cultural factors but planned economies have and often exercise the potential to let political goals dominate in making production allocational or distributional choices Indeed it is difficult in practice to separate out what are political and what are economic decisions in planned systems
