THE ACCOUNTING EQUATION

Definition of the Accounting Equation

The accounting equation is the basis upon which the double entry accounting system is constructed. In essence, the accounting equation is:

$$\text{Assets} = \text{Liabilities} + \text{Shareholders' Equity}$$

The assets in the accounting equation are the resources that a company has available for its use, such as cash, accounts receivable, fixed assets, and inventory. The company pays for these resources by either incurring liabilities (which is the Liabilities part of the accounting equation) or by obtaining funding from investors (which is the Shareholders' Equity part of the equation). Thus, you have resources with offsetting claims against those resources, either from creditors or investors. All three components of the accounting equation appear in the balance sheet, which reveals the financial position of a business at any given point in time.

The Liabilities part of the equation is usually comprised of accounts payable that are owed to suppliers, a variety of accrued liabilities, such as sales taxes and income taxes, and debt payable to lenders.

The Shareholders' Equity part of the equation is more complex than simply being the amount paid to the company by investors. It is actually their initial investment, plus any subsequent gains, minus any subsequent losses, minus any dividends or other withdrawals paid to the investors.

You can see this relationship between assets, liabilities, and shareholders' equity in the balance sheet, where the total of all assets always equals the sum of the liabilities and shareholders' equity sections.
