#### a. Use of an Interpreter to Advocate for Clients

- i. Interpreters should not be from the same community as the client
- Differences in socioeconomic status, religious affiliation, education level, and spoken dialect can result in translation barriers
- Federal government mandates require agencies to have a plan that will improve access to federal health care programs for individuals who have limited English proficiency
- iv. Subcultures might have conflict

- Amantadine, rimantadine, and ribavirin may be prescribed for treatment and prevention of influenza

- Begin antiviral medications within 24 to 48 hours after the onset of manifestations
- iv. Influenza vaccines: quadrivalent and trivalent vaccines are prepared yearly depending upon the suspected strain of influenza expected to appear

- Very dangerous has because it binds with hemoglobin and ultimately reduces the oxygen supplies to the tissues in the body
- ii. Cannot be seen, smelled, or tasted
- Manifestations: nausea, vomiting, headache, weakness, unconsciousness
- iv. Fatal with prolonged exposure
- v. Ensure proper ventilation when using fuel-burning devices
- Gas-burning furnaces, water heaters, and appliances should be inspected annually
- vii. Carbon monoxide detectors should be installed and inspected regularly

#### a. Preventing Disease Transmission

- Airborne precautions are not needed in the home setting because family members have already been exposed
- ii. Exposed family should be tested for TB
