late nineteenth century and is now intimately linked with the rebirth of China as a major maritime power; Professor Samuels gives a fascinating insight into China's ocean policy as expressed in UNCLOS III (pp. 118-136) and her attitude towards the definition of her southern maritime frontier (pp. 137-153). He also provides a useful appendix on the search for offshore oil reserves in the area (at p. 154) and the book has a select bibliography, a gazetteer and maps. This is an excellent pioneering introduction to a complex dispute with few clearly delineated claims in an inter-ocean basin with obvious political and economic potential for future tension and conflict.

The present volume is a welcome continuation of A Calendar of Soviet Treaties 1917-1957.

published in 1959 and augmented for several years by Ginsburgs in Osteuropa Recht. Although the legal division of the USSR Ministry of Foreign Affairs has succeeded commendably in reducing the

gap of its treaties in force series, 35 volumes to date, that series contains only a small fraction of Soviet international treaties, as does the United Nations Treaty Series. There is no comparable calendar published in the USSR, the volume under review thus constituting the most comprehensive listing of treaties contracted by the Soviet Union anywhere.

The compilers' definition of "treaty" transcends that of the Vienna Convention on the Law of Treaties and the 1978 USSR Law on the Procedure for the Conclusion, Ratification and Denunciation of International Treaties to include "quasi-agreements" such as joint communiqués,

joint statements, memoranda, and so forth. Since this is an unofficial compilation, the user can only

greet this broad definition with approbation, although analyses of Soviet treaty behaviour based on the Calendar would have to make appropriate allowances.

The format of the predecessor Calendar is followed. Documents are ordered chronologically by date of signature, with a concise summary of the purpose or nature of the treaty, and citations to texts and references. Emphasis in the latter is upon Soviet sources, which are extensively covered; for eign language sources or translations are selectively included, with some startling omissions. There is a

country/organisation index.

A fine addition to the corpus of reference aids on socialist approaches to international law, one hopes the compilers will continue to bring the Calendar down to the present.

This is a brief account of how American legal assistance programmes designed to transfer American

legal services and know-how to certain of the Latin American countries (Brazil, Chile and Colombia) failed to produce the result envisaged by American lawyers. In his fact-finding search aimed at an appropriate evaluation of such ventures, James Gardner established, inter alia, that "the American legal missionaries had carried abroad the patented medicine of social engineering and rule-skeptical, instrumental legal thought only to learn that this was not a cure but a disease—one that took on a virulent form in tropic, authoritarian climates" (p. 11).

The book has two Parts: Part I is devoted to a critical analysis of the history of American legal assistance to Latin America, in particular, Brazil, Chile and Colombia; Part II includes an analysis of the flaws of American legal models and American legal thought, especially in the context of Latin American experience.
