dence apply at a deposition, except Evid. R. 103 (regarding rulings on evidence) and Evid. R. 615 (regarding separation of witnesses).

- Rule 33(A)(2) amended to permit service of interrogatories on parties other than the plaintiff only after service of the summons and complaint upon that party.
- Rule 34(B) amended to permit service of request for production of documents or inspection and copying on parties other than the plaintiff to be made only after service of the summons and complaint upon that party.
- Rule 36(A) amended to permit service of request for admissions on parties other than the plaintiff to be made only after service of the summons and complaint upon that party.
- Rule 62(A) amended to allow a party to move to stay execution of judgment, or any proceedings to
