# Corporate Killing as a Corporate Governance Issue

#### Alice Belcher\*

In May 2000 the government proposed the introduction of a new offence of corporate killing founded on the concept of "management failure". Two specific corporate risks are investigated; the risk that the company's operations will kill one of its employees or a member of the public and the risk that the company will be convicted of an offence indicating corporate responsibility for that killing. The article demonstrates, firstly, that the risks associated with corporate killing fall within the ambit of the Turnbull Guidance. More importantly, it uses this particular, not directly financial, example to illustrate the proposition that Turnbull should not be associated with closure; rather it should be associated with the opening of a new level of corporate governance debate that will focus on corporate behaviour rather than corporate policy.

#### Introduction

t the time of its publication in 1999, the A Tumbull guidance on the internal control provision of the Combined Code was described in Accountancy as "the last piece in the corporate governance jigsaw". This description suggests that the UK corporate governance picture should now be clear. However, this article argues that it is wrong to associate Turnbull with closure. Rather it should be associated with the opening of a new level of corporate governance debate that will focus on corporate behaviour rather than corporate policy. During the year 2000, listed companies had to consider how to implement the risk-based approach to designing, operating and maintaining a sound system of internal control described in Turnbull.

In this paper two specific corporate risks are investigated; the risk that the company's operations will kill one of its employees or a member of the public and the risk that the company will be convicted of an offence indicating corporate responsibility for that killing. In England and Wales, it is possible to

convict a company of manslaughter, but successful prosecutions are rare. Under the "identification principle", before a company can be convicted of manslaughter, an individual who can be "identified as the embodiment of the company itself" must first be shown him or herself to have been guilty of manslaughter (Attorney General's Reference (No 2 of 1999) [2000] 3 All ER 182). In 1996 a Law Commission Report recommended the introduction of a new offence of corporate killing that does not depend on the identification principle. The proposed new offence is founded instead on the concept of "management failure". This is explained in terms of a failure in the way in which the company's activities are managed or organised. In May 2000 the government took the Law Commission's Report off the shelf and proposed to introduce the offence of corporate killing. Legislation on the proposed new offence was not included in the November 2000 Queen's speech, but pressure for change strengthened in the latter part of 2000 with the Hatfield rail crash and the resulting public pre-occupation with railway safety.
